AGM Report 2019

1. Based on the the events completed this year and a projection of the remaining expenditures, financially LEPAC has had a successful year.
2. Fundraising activities related specifically to the Fun Lunch Program, Halloween Dance and the Book fair have been very successful due to the dedication of the volunteers that put the events on.

3. Projections have the current year financial results at a break even which is what the current year budget goal was.
4. Proceeds received will be in excess of what was budgeted (removing expected fundraising goals for the AV system) which has allowed LEPAC to help fund and additional \$3,000 from the current year surplus towards the installation of the Gaga Ball courts.
5. Only significant variation in the budget was funding for the AV system for the Gym. \$10,000 was budgeted as fund to be raised with an expenditure of \$10,000 - A grant LEPAC was hopeful to receive was denied therefore there were no significant funds raised. Expenditure for the AV system at this time will be the \$1,600 projected to be raised from the Thrifty's Smile Cards.
6. Expected cash balance at the end of the year is expected to be just over \$12,000. Balance at the beginning of the year was \$12,564.

- October 2018 the committee reached out to Gregg Ferrie (IT Director for the District) regarding the domain name changes and rebranding to "Saanich Schools" to see if there was any impact on security / safety as a result of these changes.
 - He indicated that the changes had no impact of security but informed the committee that the District had hired a new Manager of Information of Technology who would be working on reviewing existing systems and developing ways to ensure greater rigour around internet security
- Over the fall of 2018 the committee worked with school administration and Telus WISE to arrange for presentations on internet safety and cyberbullying for Grade 4-5 students as well as for parents. The presentations took place and the end of January 2019.
- In November / December 2018 the committee was made aware of a safety audit conducted by parents that resulted in accessing pornography on school computers. The committee engaged parent contacts and administration and was successful in having increased filtering put in place by the District.
 - An audit conducted in December 2018 as a follow up revealed that inappropriate images were no longer easily accessible.
 - The committee followed up with Gregg Ferrie to get a high-level overview of the technical changes that were made that resulted in this positive result.

The following initiatives were supported this year:

1. Facebook Page: Continue to use to provide information and sharing of PAC initiatives to Lochside families.

2. Walk and Wheel to School Week (October 1-5, 2018). As our school participated in the Active Routes to School program in the Spring of 2018, the CRD and Public Health offered to host Celebration Stations on Wednesday, October 3, 2018. We had staff, parents and students handing out stickers each morning and students could place their sticker on our tracking poster. We tracked 630 active travelers during this week and have registered with the CRD to participate in Walk and Wheel to School Week in October 2019. We also continued to promote Walking & Wheeling Wednesdays throughout the school year on our Facebook page and through the Weekly Update.

- Suggest add 'Waste-free' as an initiative for Wednesdays as well (i.e. for lunches and snacks).

3. Fresh To You Fundraiser (October/November 2018): We pre-sold 24 produce bundles plus \$363 worth of produce on and after our delivery day. Total earnings were \$559.80 with half of the amount supporting the Grade 5 Camp Thunderbird trip.

Suggestions for next year:

- Jodi is willing to help coordinate this fundraiser for 2019.
- We would like to use the PAC Square on delivery day, as many people do not carry cash.
- We would like the produce bundles taken to classrooms for parents to pick up there, to decrease our demand for volunteers on delivery/pick-up day.

4. Games on the Green changed to Games in the Gym this year as we had difficulty recruiting parent volunteers for structured activity outside, 2 mornings/week, before school. Games in the Gym was ran from January 8 to March 14th and April 2 to 30th on Tuesdays and Thursdays from 8-8:30 am. We used Sign-Up Genius to recruit 3 parent volunteers/shift, to help supervise the

unstructured play. Kindergarten students were escorted to their classrooms after each session. We continued to have trouble recruiting adequate parent volunteers for this initiative.

Suggestion for next year:

- Offer this before school active opportunity daily as a staff-led initiative.

5. BC School Fruit & Vegetable Nutritional Program: Supported this program by washing and distributing produce to classrooms 1-2x/month. We need to recruit a new coordinator for next year. The coordinator needs their Food Safe Level 1 certification.

6. SPUD Fruit & Vegetable Fundraiser was promoted in the Weekly Update as an ongoing fundraiser. This has not been a successful fundraiser, but does not require additional volunteers. The SPUD Fundraising Coordinator is Sebastian Mather (c. 604 215 7783 x250 | e. sebastian@spud.ca). He can provide promotional materials or donations if this fundraiser continues next year.

7. This has been the second year that we were unable to support a Triathlon Club for grades 3-5 due to no parent volunteers for a club manager and coach. Cordova Bay Elementary offers this club as a staff-led option.

8. Promoted World Cups Youth Soccer Festival (April 19-20, 2019). Our school came 3rd in the school registration challenge.

9. Unplug & Play: Promoted as a school-wide playdate on Sunday afternoons at McMinn Park from April 28 – October 20, 2019.

10. A school team for the TC 10k Thrifty Foods Kids Run (April 28th) was organized. We only had 2 students register.

11. Promoted Screen Free Week (April 29-May 5) for time outside of school. Provided a list of screen-free activities plus ballots to enter a daily draw for prizes including donated books, toys and recreation centre passes. Over 250 entries were collected over the week.

12. Promoted Bike to School Week (May 27-31, 2019).

13. Will organize races and games for school year-end BBQ. We have sporting equipment stored outside in the green bin by the upper basketball court and will provide the keys to the new coordinators.

Considerations for the 2019-20 School Year:

1. Try to recruit new members by providing information about the committee's initiatives to new Kindergarten families and include in the PAC's Welcome Package.

2. Consider organizing a Family Games in the Gym Night in the winter, as an active alternative to a movie night. The gym could be opened up for unstructured play plus games (i.e. dodgeball, basketball, floor hockey, etc.)

3. Connect with a 'Health Champion' teacher to help share initiatives with other staff members.

COPAC Rep: Reet Dangerfield & Marissa Cameron

COPACS is the Confederation of Parent Advisory Councils for Saanich. There were 8 COPACS meetings this year, one per month from September through to June with the exceptions of December and March. Lochside has had representation at each one of the meetings.

At the monthly COPACS meetings there is representation from the District administration, CUPE, Saanich Teachers Association, and Saanich School Board Trustees. There was a presentation by Tara Logan from Lotus Village on mindfulness teaching in schools, a presentation by Carly Hunter, Director of Instruction on online resources that are available to support the new curriculum and a presentation by Superintendent Dave Eberwein on a new French Immersion entry lottery system that was implemented this year.

COPACS meetings are a great opportunity to exchange views and find out what is happening with other schools in SD63 as well as what is happening at a district level from the key players in our school district. The meetings also provide an opportunity to meet other parents from our district and learn about their initiatives and resources.

This year was an election year for the SD63 Board Trustees. As such, a large


